#### Kirkland Course for Women to be Profiled in New York Law Journal



An innovative communication skills training course sponsored by Kirkland's Women's Leadership Initiative (WLI) was profiled in the February 2008 edition of the *New York Law Journal* focused on women in the law.

New York Corporate Partner Kim Taylor bylined an article on the Firm's

"Communication Skills for Lawyers" course taught by Lane Bowes, an attorney and co-founder of LawSpeak. The course, now in it's fourth year, covers techniques of effective oral communication in a law firm setting and provides tools and strategies to enhance women attorneys' ability to speak clearly, confidently and persuasively.

Following the session, course participants have the opportunity to practice and apply the skills they learned in individual, hour-long training sessions with Lane.

Interest in the Communication Skills course spans practice areas and class years, and participation steadily increases every year the course is offered. Everyone from junior associates to senior partners finds value in learning how to better give and receive feedback, establish rapport with judges, juries and clients, outline and simplify complex legal issues, develop a better understanding of body language, and identify and develop their own unique speaking style.

About our efforts to advance women at the Firm, Bowes said, "Kirkland's WLI and their Training & Development professionals bring an unparalled level of sophistication and innovation to legal training. They make a special effort to tailor their programs to match the firm's culture, and the results are exceptional."

Kirkland was named one of

The DAP helps Posse identify exceptional students who might be missed by the traditional college admissions process.

#### **Issues Facing LGBT Women**

On November 15, New York Corporate Partner Ashley Gregory sat on a panel entitled "Queer Women in the Private Sector" at New York University School of Law.

The panel consisted of partners, associates, and law firm administrators from various firms and was open to LGBT women from New Yorkarea law schools. The aim of

the event was to initiate a dialogue about LGBT women in law firms -- the challenges they face and the common misconceptions about them. The discussion topics covered included employee benefits for LGBT attorneys, networking, and career advancement.
