

#### Kirkland Panels Discuss Same-Sex Marriage Cases at **U.S. Supreme Court**

Kirkland's LGBT Subcommittee hosted two recent Diversity Leadership Series (DLS) panel discussions focused on the same-sex marriage cases at the U.S. Supreme Court. On July 16, 2013, the Firm's San Francisco office hosted The Williams Institute for an event titled "The Road Ahead: The Supreme Court Rulings on Proposition 8 and DOMA." David Codell, Visiting Arnold D. Kassoy Senior Scholar of Law and Legal Director of The Williams Institute, served as moderator for the panel that included Christopher Stoll, senior staff attorney at the National Center for Lesbian Rights (NCLR), and Christine Van Aken, deputy city attorney for the city of San Francisco. Christine was counsel for the plaintiff-intervenor in Perry v. Hollingsworth, the Supreme Court case that successfully challenged Proposition 8.

On May 13, 2013, Kirkland's New York office hosted an event titled "Marriage Equality at the Supreme Court: What Should We Expect?" with Michael Kavey, lecturer-in-law at Columbia Law School, and Rose Saxe, senior staff attorney with the ACLU Lesbian Gay Bisexual Transgender & AIDS Projects. Rose served as co-counsel for Edie Windsor in Windsor v. United States, the Supreme Court case that challenged Section 3 of the Defense of Marriage Act. Both panels were simulcast to all of Kirkland's U.S. offices.

Kirkland filed amicus briefs on behalf of The Williams Institute in both the Windsor and Perry matters.

Kirkland sponsored the National Center for Lesbian Rights' (NCLR) 36th Anniversary Celebration on May 18, 2013. The Kirkland table included litigation partners Elizabeth Deeley and Nicholas Kacprowski, intellectual property partners Sarah Piepmeier and Jared Edgar, and summer associate Shayne Henry, as well as

Hilary Ware, vice president and associate general counsel at Netflix, Inc., and Karen Robinson, director of litigation at Adobe and a former Kirkland partner. At the VIP reception prior to the event, NCLR presented Kirkland with a Community Partner Award. This award recognized Kirkland's efforts as pro bono counsel for a variety of NCLR matters, including significant lawsuits on behalf of Jennifer Tobits and Dynasty Young. The Tobits lawsuit, which has now been successfully resolved in Illinois Probate Court, resulted in an important judicial recognition of the rights of a surviving spouse of a same-sex couple who had married in Canada under the Illinois Religious Freedom Protection and Civil Union Act. The Young lawsuit, which challenges a school district's discriminatory treatment and failure to protect an openly gay former student, recently announced a settlement agreement in federal court in Indianapolis that expunges the student's expulsion from his school records and rewards him \$65,000 in compensation.

#### Kirkland and ACLU Secure Preliminary Injunction in Michigan Benefits Lawsuit

Kirkland and the American Civil Liberties Union (ACLU) achieved an important victory when a federal judge in the U.S. District Court for the Eastern District of Michigan granted a preliminary injunction barring the State of Michigan from enforcing P.A. 297, which prohibits public employers from extending medical and other benefits to same-sex families. The ACLU and Kirkland filed the lawsuit on behalf of five gay and lesbian public employees, as well as their long-term domestic partners. Litigation partners Donna Welch, Amy Crawford and Bradley Weidenhammer, intellectual property associate Scott Lerner, and litigation associates Debra Lefler and Russell King lead the Kirkland team representing the employees pro bono.
