Kirkland Named to The American Lawyer's A-List



In June, *The American Lawyer* released the law firms comprising its 2014 A-List. Kirkland has once

again been named to the coveted list.

The A-List aims to identify the country's most well-rounded law firms via a measure of their success in four core areas: financial performance, pro bono, diversity and midlevel associate satisfaction. To determine the A-List, *The American Lawyer* pulls from its four surveys that rate Am Law 200 firms' performances in these areas. The total score is calculated by doubling each firm's RPL and pro bono scores and adding those to the firms' associate satisfaction and diversity scores. The 20 top-scoring firms comprise the A-List.

Letter from the Co-chairs of the Diversity Committee

Kirkland improved nine spots on *The American Lawyer*'s Diversity Scorecard survey this year, helping to secure the Firm's position once again on the magazine's coveted A-List of the 20 most well-rounded law firms (page 1). Our journey to improve and foster diversity is ongoing, but markers like AmLaw's Diversity Scorecard, Yale Law Women's Top 10 Family Friendly Law Firms and *Working Mother*'s 50 Best Law Firms for Women (page 7) — two other features in which Kirkland was recognized — among other surveys, validate our direction and provide insight into areas of untapped potential within law firms.

For instance, Yale Law Women's list includes law firms with high family-friendliness indicators, such as part-time and flex-time options, caregiver leave policies and childcare availability, as well as indicators of gender equality in partnership promotions and composition of leadership committees. Kirkland was one of five firms recognized for promoting more than one partner who was or has been on a part-time or flexible full-time schedule.

Our commitment to diversity extends beyond policies for existing employees. Our pipeline efforts continued this summer with leaders of our Women's Leadership Initiative and members of diverse and LGBT affinity groups in our U.S. offices holding receptions for rising 2L diverse and women law students from top feeder schools. These targeted receptions help to forge early and lasting connections with high-caliber diverse and women candidates as they consider employment options heading into the fall recruiting season.

Outside of policies and recruitment, we continue to execute a wide variety of programming, the highlights of which are included in this edition of Diversity Digest. We hope you enjoy it, and thank you for your collaboration in promoting diversity and inclusion throughout the Firm.

Kirkland DLS Hosts Discussion on Historic HBCU Equality Lawsuit

On June 10, 2014, as part of Kirkland's Diversity Leadership Series, litigation partner Mike Jones spoke about the Firm's landmark victory in a pro bono civil rights case

on behalf of students at Maryland's historically black colleges and universities (HBCUs). Mike represented the Coalition for Equity and Excellence in Maryland Higher Education against the State of Maryland for the state's failure to completely dismantle its formerly segregated system of higher education. The court ruled that Maryland violated the constitutional rights of students at Maryland's four HBCUs by unnecessarily duplicating their programs at nearby white institutions, a practice that began during the era of de jure segregation. The event was held in the Washington, D.C., office and was videoconferenced to more than 100 attendees including Kirkland attorneys, summer associates and pro bono fellows in the United States.

Kirkland Hosts Chicago Scholars Interview Night

On March 12, 2014, attorneys and staff in the Chicago office volunteered as interviewers at the Chicago Scholars Interview Night, during which 32 local high school students interviewed for the Chicago Scholars program.

The program helps disadvantaged students overcome barriers to attending and succeeding in college. Students enter the five-year program as high school seniors, and they attend seminars, workshops and mentoring sessions that help them apply to and be accepted by universities, graduate on time and transition into their post-collegiate lives.

On March 14, 2014, the San Francisco office hosted its sixth annual workshop as part of its involvement in the National Association for Law Placement, Inc. (NALP) Street Law Pipeline program, which pairs law firms with local diverse and disadvantaged high schools to teach students about substantive areas of the law, the legal profession and legal career pathways. This year, approximately 70 juniors from San Francisco's Leadership High School visited Kirkland, where they participated in two workshops: a copyrights mock trial and a contracts negotiation. Firm attorneys, University of California, Berkeley, School of Law students and University of California, Hastings, College of the Law students facilitated the workshops, which built off of two classroom visits that took place earlier this spring at their school. Following the two workshops, students enjoyed lunch and networking with the volunteers. Kirkland was one of the first law firms to sign up for this project and has worked with more than 475 youth in the Bay Area and Silicon Valley through the program.

Kirkland Secures Victory in Indiana Same-Sex Marriage Case

The U.S. District Court for the Southern District of Indiana ruled on June 25, 2014, that Indiana's ban on same-sex marriage is unconstitutional, finding that the ban interfered with a person's fundamental right to marry under the due process clause and violated the equal protection clause. Indiana has appealed the ruling, and the case is now pending before the U.S. Court of Appeals for the Seventh Circuit.

Kirkland, along with Lambda Legal, represented five couples in this case. The team was led by intellectual property partner Jordan Heinz and included intellectual property partner Brent Ray, litigation associates Dmitriy Tishyevich, Melanie MacKay and Scott Lerner, and legal assistant Emily Malloy.
